FAMILY SUCCESS STORY: THE SALDAÑAS

Being on the receiving end of a devastating diagnosis like cancer is an unthinkable crisis in and of itself. Now imagine being a mother of three, out of work, all while trying to parent children as they aim to stay on top of school and appointments, while still being kids.

THEY WERE DEALING WITH SO MUCH. I STARTED BY ASKING:

HOW can I HELP?

That's exactly the burden the Saldaña family was carrying when they first met Linda Solis, family navigator at Children's Home Society of Washington (CHSW), who began working with the family to provide holistic support through the Family Success Hub Model.

Once they started talking, it didn't take long to realize just how dramatic and entangled their challenges were—not just with the medical systems, but at school, and at home. They were overwhelmed.

ike Linda, the Saldañas spoke Spanish at home. Linda learned how that language barrier made it difficult for them to navigate the health care system and access the most basic tools to fight their mother Maria's disease. Linda helped connect the family with regular translation support so they could stay on top of treatment.

Through the Hub's extensive network of resources and partnerships, Linda knew exactly who to call for everything from school support to playdates and behavioral health resources. As they continued to meet each week, Linda learned just how much the diagnosis had affected each member of the family, and started working with the Saldañas to set goals. She talked to each of them about their feelings when they were hopeless, or sad.



n August 2019, Maria Guadalupe Rodriquez Lara lost her battle with cancer. The family was devastated, as any family would be.

In the face of such a trauma, Linda knew the family would need more help than she alone could provide, so she assisted in connecting the Saldañas to cancer counseling at the hospital where their mother was being treated. She checked in each week, sometimes joining them for walks outside, and helped the girls write letters to their mother to process their grief. She knew she couldn't fix everything, but she would help them work through all the things they *could* control.

While the Saldaña's story is unique to them—it speaks to families across our state searching for the tools to be the best they can be, under circumstances they know best. It shines a light on the reality that when a crisis meets one member of a family, it affects everyone. That's why the Family Success Hub Model is built around advocates like Linda who can support each member, helping families stay strong and thrive.

At Children's Home Society of Washington, we can't cure a devastating disease. But we can walk alongside every family who comes to us with a challenge they can't solve alone, because no family should have to. Whether a parent is worried about how to escape an abusive relationship, a child is struggling with bullying at school, or a baby misses a major developmental milestone—families need unique, tailored, comprehensive support to thrive. We are here to make sure they succeed in doing just that.

A YEAR IN REVIEW

CHSW 2019 2020

2020 was a monumental year. The world screeched to a halt in March 2020 due to COVID-19. Despite the challenges, CHSW pivoted quickly to offer services virtually across the state, to ensure our most impacted populations families affected by job loss or illness, children and families at risk for homelessness, and those nearing a point of crisis prior to the pandemic who now faced critical need—had the support they required to pull through to the other side of the pandemic.

There is no right way to be a family —but there is a right way to support one. For the children with the greatest needs today, for the families who deserve a better future, and for the communities we are all a part of—we will be here to help families reach their full potential, because it is the right thing to do.
